

## INVESTMENT OBJECTIVE

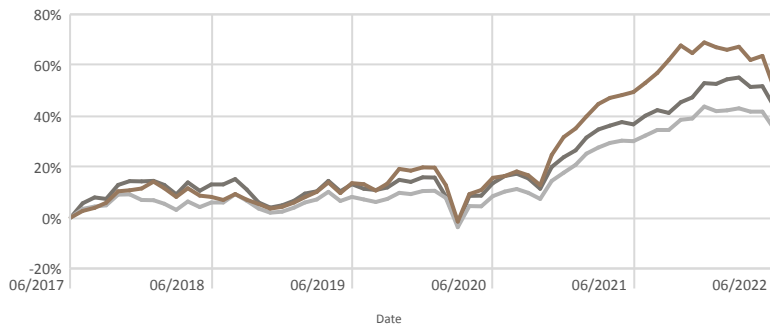
The Centaur BCI Flexible Fund is a flexible portfolio that aims to provide investors with high long term capital growth.

The manager may include forward currency swaps, interest rate and exchange rate swap transactions.

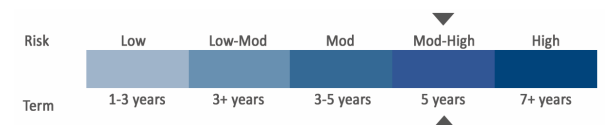

## RISK PROFILE



### Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio.
