

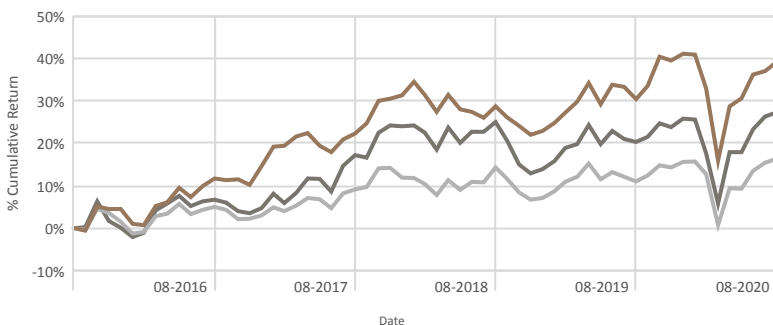
## INVESTMENT OBJECTIVE

The manager may include forward currency swaps, interest rate and exchange rate swap transactions.

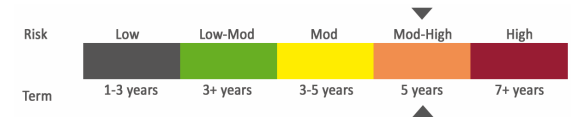

### Medium - High Risk
